Following the teaching sessions there will be 2nd Workshop discussing the issues of financing small and medium-sized enterprises (SMEs) from financial markets from the point of CMV. We will visit a family enterprise undertaking business in hotel and travel services and stroll through winter Prague decorated for Christmas (Old Town, Lesser Town).
- **December 6, 2018** (Thursday) - Lectures given by visiting professors in Bachelor Programme (VSFS a.s., Estonská building) and in Master Programme (VŠFS, a.s., Vltavská building). 3rd Workshop will discuss the issues of Start-ups, regional development and public administration. Attendees shall introduce the existing and possible future common topics and ideas for future cooperation in R&D. Closing ceremony, delivery of attendance certificates.
- December 7, 2018 (Friday) - Departure
